The following amendments *mutatis mutandis* are made for compliance. The Prospectus 2025 – 2026 Postgraduate PG Programme be read with this Corrigendum.



<p>16. Postgraduate Programmes</p> <p>To ensure equity and equality of opportunity for all aspiring candidates to secure admission in the University, competent authority made a decision as follows:</p> <p>a) Those students who have once availed of an opportunity of pursuing a UG, PG or PhD course/ programme in the English stream or in a foreign language stream / or any other programme shall not be eligible for admission again if they repeat pursuing the same level course / programme in the University.</p> <p>b) Those students who already availed of an opportunity of pursuing a course/ programme of the higher level earlier, but are now applying for a lower level course / programme in the University shall not be eligible for admission.</p> <p>c) Those students who are employed full-time shall not be eligible for admission into a programme, unless they produce an evidence of duty leave for the duration of the course from their employer.</p> <p>d) As there is a stiff competition for the hostel accommodation, the same will not be made available to any of the students falling in the any of the above categories.</p>		<p>16. Postgraduate Programmes</p> <p><i>Those students pursuing a graduate/ master's/ at the University in English stream or in foreign language and concomitantly secure B1 level or above in another foreign language other than the programme in English stream/ foreign language, which he/she has pursued at the University; such student is allowed to pursue Master's programme at the University in that foreign language, subject to the availability of vacancies, where the level required has been secured by the student, and provided that the B1 level or above that the student attained shall only be from a recognised State/ Central level institution or an Advanced Diploma/ Degree/ Level offered by the Embassy concerned or a recognised/ authorised Centre of Learning accredited by the Embassy concerned of the foreign language, and where such Advanced Diploma/ Degree/ Level shall be secured by the student without prejudice to the class work and its incidental fulfilments of the substantive programme, which the student pursued and completed at the University.</i></p> <p>i). In such case, production of the original certificate of the Advanced Diploma/ Degree/ Level required to be fulfilled by the student shall be mandatorily furnished at the time of Provisional Admission awarded to the candidate for which no request for relaxation will be entertained.</p> <p>ii). The student who is facilitated admission to a Programme in terms of the above rules will not be provided Hostel accommodation at the University.</p> <p>iii). Those students who are employed full-time shall not be eligible for admission into a programme, unless they produce an evidence of duty leave for the duration of the course from their employer.</p>
