Course description	<p>i) A Brief Overview of the Course:</p> <p>This course provides an in-depth knowledge of the golden age of Arabic literature. The Abbasid era is widely regarded as a peak period in the intellectual and cultural history of the Islamic world, marked by exceptional literary productivity and diversity. The course investigates the social, political, and cultural conditions that led to this literary renaissance, particularly the Abbasids' patronage of learning, translation, and scholarship.</p> <p>A focus is on the emergence and refinement of various literary genres, including classical poetry, philosophical and scientific prose. The course also explores the evolution of literary criticism and rhetorical styles that defined the aesthetics of Arabic literature during this period .Key literary figures like Bashir Bin Burd, , Abu Nuwas, abu Tammam ,Al-Mutanabbi, , Al-Jahiz, and Badi al-Zaman al-Hamadhani are studied in detail.</p> <p>The course also highlights the Abbasid translation movement, emerge in institutions like the Bayt al-Hikma in Baghdad. This movement brought Greek, Persian, and Indian philosophical and scientific works into Arabic, enriching Arabic prose with new vocabulary, concepts, and styles. The course also explores how these texts reflect the multicultural and multi-religious fabric of Abbasid society.</p> <p>At the end of the course, students will have a deep appreciation of the Abbasid contribution to classical Arabic literature, the artistic excellence of its writers, and the enduring legacy of this era in shaping Arabic literary traditions across the centuries.</p>

Course description	<p>i) A Brief Overview of the Course:</p> <p>The Indians produced a valuable literature in Arabic which includes thousands of Arabic manuscripts and creative works both in prose and poetry forms. There are hundreds of libraries across the country which houses their masterpieces. The focus of this course is to familiarize students with the literary and scholarly works done by Indian writers and poets.</p> <p>ii) Objectives of the Course in terms of Programme Specific Outcomes (PSO):</p> <ol style="list-style-type: none"> 1. Course description	<p>i) A Brief Overview of the Course:</p> <p>This course is designed to equip students with a comprehensive understanding of the principles, approaches, and methods used in academic research across disciplines. The course is designed for students of postgraduate level. The course begins with an introduction to the philosophy and purpose of research, emphasizing the importance of inquiry, objectivity, and systematic investigation in academic work. Students are introduced to different types of research methodologies, including: Qualitative research, Quantitative research and mixed methods.</p> <p>The course makes students aware of the stages of research design, starting with problem identification and formulation of research questions. Students learn how to conduct a literature review, assess existing studies, and do their research within a broader academic context. The course familiarizes students with ethical considerations in research. Topics include informed consent, confidentiality, plagiarism, and responsible data handling to ensure students understand the moral responsibilities involved in scholarly work.
