Course description	<b>i) Course Description</b> This course introduces students to the fundamental structures of the Spanish language through the study of morphology (word formation) and syntax (sentence structure). Students explore how Spanish words are built from roots and affixes, how grammatical categories such as tense, aspect, mood, gender, and number are expressed, and how these elements interact within larger syntactic constructions. The course provides a systematic examination of Spanish sentence patterns, including phrase structure, verb agreement, pronominal systems, word order, and the role of functional categories.  <b>ii) Objectives of the course in terms of Programme-specific Outcomes (PSO of the Programme under which the course is being offered)</b> <ul style="list-style-type: none"><li>➤ Identify and describe the main components of Spanish words, including roots and affixes.</li><li>➤ Analyze key Spanish word-formation processes, such as inflection and derivation.</li><li>➤ Understand basic sentence structures, including noun phrases, verb phrases, and clauses.</li><li>➤ Recognize patterns in Spanish word order and the role of functional elements like determiners, etc.</li><li>➤ Apply linguistic analysis to explain Spanish morphological and syntactic patterns.</li></ul>
